- **3.** This award is not intended to recognise long or distinguished service.
- 4. Only one SAIEE President's Award shall be made in one calendar year.
- 5. This award shall be made to individuals only.
- 6. The SAIEE Office Bearers shall decide upon the nature of the award in any given year.
- **7.** The Award shall be presented at the SAIEE Annual Awards on the 14<sup>th</sup> of March 2025. Venue TBC
- 8. Any individual may make nominations for the award. A nominee shall not be his/her own nominator. If the nominator is not a SAIEE Member, such a person's nomination shall be counter-signed by an SAIEE Member.
- **9.** Nominations must be submitted before 7 February 2025 on the attached prescribed nomination form.
- **10.** The judging panel's decision is final; no correspondence will be entered.
- **11.** The President's Award is the top award of the SAIEE.
